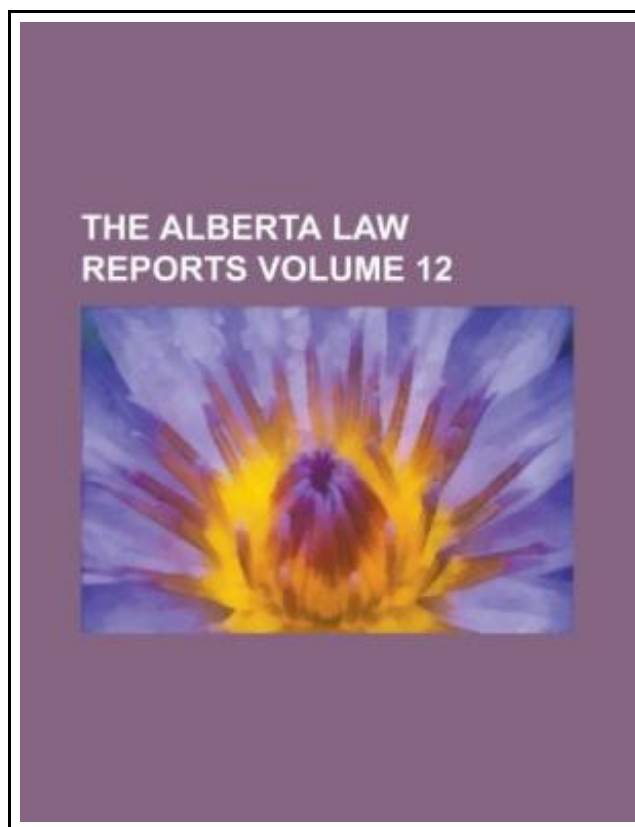

An estimate was made by the contractor on March 28, 1913, and on May 2, 1913, the defendant requested the plaintiff to proceed with the work, the church to be built according to estimate A but changing roof construction to wood or steel, approximate cost 61, 572. The defendant undoubtedly had power to enter into any contract it might see fit for the erection of a church. It is within the powers conferred by the Act of 1895, as amended, and is incidental to the objects of an ecclesiastical corporation of this kind. There were no meetings of the council of the parish held at which the Bishop, parish priest and wardens were all present and no resolutions of the council having the administration of the parish were held formally authorizing the making of the contract. No such formalities were required or provided for by the Act or the canonical letters erecting the parish. The Bishop consented to the erection of the church and left the details of the contract to the...
